Mike Kintner Named IDALS Emerald Ash Borer & Gypsy Moth Outreach and Regulatory Entomologist

I am thrilled to announce that effective Friday, November 8, IDALS regional entomologist Mike Kintner transitions into a new role for the Iowa Department of Agriculture & Land Stewardship (IDALS). Mike will be the IDALS emerald ash borer (EAB) and gypsy moth (GM) outreach and regulatory entomologist. This is a new position in IDALS, as we've passed the tipping point and tracking and dealing with these two insects is a full-time job. Mike will work out of the Quad Cities area, covering eastern Iowa.

Mike will work directly with industry and persons in need of regulatory assistance, as well as follow up on citizen calls concerning suspect trees.

Mike has been with IDALS since 2008, covering

the southwest region, providing nursery inspections, phytosanitary certificates (export certification), and a host of other duties including European corn borer compliance activities, greenhouse inspections, gypsy moth survey, etc. Mike is well versed, with a degree in Horticulture from Iowa State University and eight years of experience in private industry before joining IDALS in 2008.

25 Counties In Ash Borer Quarantine

Officials with the Iowa Department of Agriculture and Land Stewardship have quarantined 25 counties in Eastern Iowa to help prevent the spread of the Emerald Ash Borer (EAB). There have been confirmed EAB infestations in four Eastern Iowa counties.

"This regional quarantined is designed to help prevent the spread of this destructive insect while hopefully allowing businesses to continue to function," lowa Secretary of Agriculture Bill Northey said. "This quarantine is established to make sure that any ash products that leave these counties do not spread the pest."

The regulated articles under the quarantine include EAB at any living stagee; entire ash trees; firewood of any hardwood species; any cut or fallen material of the ash; non-heat treated ash lumber with either bark or sapwood attached; and hardwood wood or bark chips larger than

one inch in two dimension.

The quarantine orders that the regulated articles cannot be moved from a county included in the quarantine unless a permit has been issued by either the Iowa Department of Agriculture and Land Stewardship or USDA Animal and Plant Health Inspection Service (APHIS), or if the article has been treated to exterminate any pests under the supervision of USDA and the Iowa Department of Agriculture and Land Stewardship.

Counties in the quarantine are Winneshiek, Allamakee, Fayette, Clayton, Buchanan, Delaware, Dubuque, Linn, Jones, Jackson, Clinton, Johnson, Cedar, Scott, Keokuk, Washington, Muscatine, Louisa, Wapello, Jefferson, Henry, Des Moines, Davis, Van Buren, and Lee.

Firewood Business Thrives During Battle with Emerald Ash Borer

While the battle against the Emerald Ash Borer is leading Heat to an expanded quarantine, it's not stopping business from wood. booming at a Jackson County sawmill.

The screeching saw tells quite a story.

"It's cutting the wood to length and then splitting it," said Derek Heiar.

It's slicing the way to Heiar's business, Iowa Firewood Products, in Preston, Iowa.

"It's crazy around here," he said.

They transform trees into safe firewood. After taking roots a decade ago, business tripled over the last two years.

"I would never have guessed it could be something like this," he said.

Long before the Emerald Ash Borer emerged, Heiar, now 30, started chopping wood in high school. These days, his eleven-person operation sells to big name clients like Home Depot.

"I would look for the origin of the wood, the county it came from, to see if it's USDA certified," he said.

It's a battle now against Emerald Ash Borer. That's why his wood spends time in kilns.

"It's going to reach a core temperature of 145 degrees for 60 minutes," he said.

Heat treatment kills bugs and makes it suitable for firewood.

"It makes us feel good knowing that we're helping to stop the ash borer from spreading," he said.

Most infestations start by people moving firewood, nursery plants or sawmill logs. That makes this business even more important.

"It could be a standing tree a week ago, and it could be packaged today," he said.

Crews turn out some 1,500 bundles each day. That fills eight semi loads every week.

It's a strategy to fight the Emerald Ash Borer while building a business.

"We're trying to slow the process of it spreading," he said. "This is what the state has to do."

lowa Firewood Products plans to expand in the coming year. It will be moving forward on the cutting edge.

AGRIBUSINESS: Ash Borer, Stink Bug Infesting Iowa

There are two significant insect pests cropping up in new areas across the state: the brown marmorated stink bug, and the emerald ash borer.


The brown marmorated stink bug is in 40 states, including lowa, and damages both corn and soybeans. However

current research is examining pest management.

Not so with the Emerald Ash Borer (EAB). It first showed up in Michigan, and within 20 to 25 vears, it had covered the whole state short of The Upper Peninsula. Iowa is a little different from Michigan, with less forested areas, but EAB's capability to bring the timber

industry to its knees prompted a 25-county quarantine earlier this month.

State entomologist Robin Pruisner says it's not just eastern lowa, where timber is a larger part of the economy, that's threatened by EAB.





"Hopefully we can slow the spread of it, which would allow for landowners and municipalities to plan for it coming there. They can take a look at what we need to inventory their trees how many ash do they have, what are we going to do, do we want to start removing some now. How do we diversify some of our urban forests. And our goal right now is

to just give more time to landowners and cities to prepare and take actions.

Words of Encouragement on the Farm Bill

On October 30th the Farm Bill Conference Committee held their first public hearing about the conference process. Nearly all of the forty-one conferees provided opening statements highlighting their priorities and concerns but the general theme was one of optimism and the need to see the process through to law.

The big obstacles to agreement remain the substantial spending differences between the House and Senate

versions for the Supplemental
Nutrition Assistance Program
(SNAP) and some concerns by
particular crop groups over the crop
insurance provisions. However, an
area of agreement, at least for the six
conferees that addressed it, was
encouragement for expanded
funding for specialty crop programs.
What made this particularly
encouraging was the fact that the

expressions of support came from both chambers and both parties.

The week before this first conference meeting the Specialty Crop Farm Bill Alliance (The Alliance), of which ANLA is an active member, submitted a letter to the House and Senate Farm Bill conferees reminding them of our specialty crop priorities and requesting their support for our programs during negotiations. Issues ANLA has often led on and, which are specified in the letter, include programs like Plant Pest and Disease Mitigation and Prevention, National Clean Plant Network (NCPN), Specialty Crop Research Initiative (SCRI) and Specialty

Crop Block Grants (SCBG).

In addition to expanded funding for these important programs, the letter reinforced the need for mandatory funding for SCRI and NCPN, a message that has been shared with legislators and their staffs during many face-to-face conversations. Mandatory funding would prevent funding gaps due to a simple extension of the Farm Bill or a continuing resolution, such as happened in fiscal year 2013.



Another theme expressed in the letter and conveyed during ANLA visits to Capitol Hill and USDA offices has been the need to maintain, and in some cases expand, the involvement of industry stakeholders in the review processes of grants and cooperative agreements. This interest is especially true in regards to SCRI and our support of the House language that

would put greater emphasis on funding industry priorities that meet a scientific meritorious threshold rather than funding interest science that may or may not meet industry needs.

ANLA and our partners in The Alliance are encouraged by the make-up of the House and Senate conference committees – largely agriculture focused legislators and are hopeful that a new Farm Bill will be signed into law before the end of the year.

Meanwhile, More Evidence that Immigration Reform Would Boost Economy

A new study and paper released by the Bipartisan Policy Center (BPC) find that immigration reform would bring significant positive impacts to the U.S. economy by growing the labor force, jumpstarting new residential housing construction and reducing deficits in the long-term. The analysis, Immigration Reform: Implications for Growth, Budget and Housing, was designed to produce a complete and balanced assessment of immigration reform's economic and budgetary impacts.

The study looked at important data sets surrounding the immigration reform debate, including tax revenues, economic growth and the impact of government spending. The associated paper was authored by immigration analysts for BPC's Immigration Task Force. The task force is co-chaired by former Secretary of State Condoleezza Rice, former Secretary of HUD Henry Cisneros, and former Governors Haley Barbour (MS) and Ed Rendell

(PA).

"[This analysis] demonstrates that under almost every plausible approach, fixing our broken immigration system will benefit our economy. It also demonstrates that how Congress crafts reform matters to the overall economic performance," said the co-chairs of BPC's task force in a letter accompanying the study. "A balanced understanding of the costs and benefits of immigration reform is crucial to this process. We believe that it is both critical and possible to develop a bipartisan approach to immigration reform and hope that this analysis is helpful to achieving this goal."

"Regardless of how it gets done, immigration reform is a pro-growth policy that will raise growth, strengthen housing markets, and firm up our nation's finances," said BPC's Douglas Holtz-Eakin.
