#### **EPA Issues Stop Sale Order to DuPont for Herbicide**

A new commercial lawn care chemical by DuPont called Imprelis has been linked to damage to coniferous trees, primarily white pine and Norway and Colorado blue spruce. Firs and yews also may be affected.

The U.S. Environmental Protection Agency (EPA) has since issued an order to E.I. DuPont de Nemours (DuPont) directing the company to immediately halt the sale, use or distribution of Imprelis, an herbicide marketed to control weeds that has been reported to be harming a large number of trees, including Norway spruce and white pine. The order, issued under the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), requires DuPont to stop the sale and distribution of Imprelis in the U.S. and outlines specific conditions to ensure that the removal of Imprelis from the market meets legal requirements.

This action follows EPA's investigation into why a large number of evergreens and other trees have been harmed following the use of the herbicide. In its evaluation, EPA is investigating whether these incidents are the result of product misuse, inadequate warnings and use directions on the product's label, persistence in soil and plant material, uptake of the product through the root systems and absorbed into the plant tissue, environmental factors, potential runoff issues or other possible causes.

The first damage reports came in late May/early June from the East Coast. Damage has now been reported in Chicago, Iowa City, and Cedar Rapids, Iowa, but there has been none in the Quad-Cities, Iowa State University/Scott County Extension horticulturist Duane Gissel said.

Bert Cregg, an associate professor of horticulture and forestry at Michigan State University, said in a Extension bulletin that it is possible affected trees could recover if they are left in place for a year to a few years, even if damage appears severe.

"Based on experience with other forms of herbicide injury and other types of environmental damage, trees with minor browning (less than one-third of the crown affected) on new growth will likely be able to push new growth and eventually 'grow out' of the damage, though this can take one or two growing seasons," he wrote.

The product was studied experimentally at Iowa State University for the past couple of years and was found to be very effective against a broad spectrum of broadleaf weeds, including ground ivy, violets and henbit, Nick Christians of Iowa State said.

"It is important to note that there are many locations where the product was used and no tree damage has occurred," he said. "Also, not all trees (in damaged areas) are damaged." DuPont released a letter to its users in June saying that "as a precaution ... do not apply Imprelis where Norway spruce or white pine are present on, or in close proximity to, the property to be treated."

On June 17, 2011, DuPont issued a letter to professional applicators cautioning against the use of Imprelis where Norway spruce or white pine trees are present on, or in close proximity to, the property being treated. On July 27, 2011, DuPont acknowledged to the EPA that there has been damage to trees associated with Imprelis use and the company had developed an internet web page to provide information and updates concerning Imprelis use.

On August 4, 2011, DuPont voluntarily suspended sales of Imprelis and announced that it will soon conduct a product return and refund program.

The pictures above were in an article about Imperilis damage to trees, written by Nick Christians with ISU's Department of Horticulture. The trees are Norway Spruce and were taken in the Chicago area. The damage appears to be systemic, meaning that the material is being taken up by the roots and translocated to new growth. On this site, about 20 trees out of approximately 120 susceptible plants were damaged. In this case, there was heavy rain after treatment that may have increased movement of the product into the rootzone.

### E-Verify Alone Will Be a Disaster - ANLA Tells Congress on Capitol Hill

On July 13, a team of green industry business owners representing the American Nursery and Landscape Association (ANLA) came to Washington to explain to Congress that mandating E-Verify, without broader labor solutions, will cost jobs and damage the economy. The ANLA team, representing the states of Maryland, Pennsylvania, and Virginia, met with 20 House and Senate offices and was part of a broader lobbying day that also included coalition partners from New England, Florida, Texas, California, and elsewhere.

The House Judiciary Committee is expected to take up H.R.2164 as early as the week of July 25. The full House could consider the E-Verify bill in September. As it stands now, the bill would require all employers to use E-Verify within three years. It provides no solution to ensure employers can find enough workers, especially for agricultural and seasonal jobs that are unappealing to most working Americans.

"As goes Georgia, so goes the nation," said Craig Regelbrugge, ANLA vice-president for government relations. Earlier this year, Georgia passed a state immigration enforcement and E-Verify law. It rapidly led to devastating farm labor shortages of 30 to 50 percent, and growers there are bracing for losses that may reach \$300 million. "E-Verify alone, in the name of creating jobs, will kill American jobs and economic activity," Regelbrugge emphasized.

The ANLA lobbying team urged a more thoughtful approach that includes measures to ensure access to legally author-

ized farm and seasonal workers. For instance, Rep. Dan Lungren (R-CA) intends to offer an E-Verify amendment that would establish a new, more flexible and market based agricultural worker program.

Julie Snyder, co-owner of Riverbend Nursery (VA) was part of the fly-in team. She shared these comments about her experience: "While it was daunting to consider a trip to Washington DC. – the time, traffic, cost, and 'who will listen to me, I'm just one person' - I can honestly say I feel I made a big difference. We touched a lot of people in just one day and shared the real stories that occur here in VA and across the nation. The people we met with were receptive, interested and appreciative, and I truly feel they will use the information we provided as an E-verify bill moves forward. I highly encourage others to make the effort. We as an industry have so much to lose. The outcome of this won't just impact our valuable current and future Hispanic workers, but all our workers and our ability to continue to operate in this industry we love."

The July 13th lobbying day was the latest of several planned for the months ahead. The next major E-Verify fly-in is being planned for the week of September 12.

#### **USDA Proposes to Restrict Certain Plant Imports**

The United States Department of Agriculture (USDA) is moving to restrict 148 plant taxa due to concerns that the plants are quarantine pests, or hosts of quarantine pests. The USDA is requesting comments on the 148 plant taxa they have determined should not be authorized for importation, pending a pest risk analysis. Comments are due by September 26, 2011. the scientific evidence they evaluated in making the determination that the taxa are quarantine pests or hosts of quarantine pests.
